



## **SCHOLARSHIP ELIGIBILITY REQUIREMENTS**

### **WYRULEC COMPANY SCHOLASTIC SCHOLARSHIPS:**

Applicant must be a senior in high school or any eligible college student and must be enrolled or planning to enroll in an accredited college or university. Four (4) scholarships will be awarded in the amount of \$1,500 each.

The applicant, their parent, or legal guardian must receive their electric service from Wyrulec Company at their primary place of residence. The applicant, parent, or legal guardian does not have to be a member of the cooperative, as long as they reside on the cooperative's service line. (Can be under a landlord or rental agreement or provided residence with employment.)

### **WYRULEC COMPANY TRADE SCHOLARSHIPS:**

For applicants planning to attend an accredited trade or vocational school. Must be a senior in high school or any eligible college student. Up to four (4) scholarships will be awarded in the amount of \$1,500 each.

The applicant, their parent, or legal guardian must receive their electric service from Wyrulec Company at their primary place of residence. The applicant, parent, or legal guardian does not have to be a member of the cooperative, as long as they reside on the cooperative's service line. (Can be under a landlord or rental agreement or provided residence with employment.)

### **WYRULEC COMPANY SECOND AWARD SCHOLARSHIP**

This scholarship has been developed for students who have already received a scholarship from Wyrulec Company in the past and wish to apply again. One scholarship will be awarded in the amount of \$1,500.

The applicant must have already received a scholarship from Wyrulec Company in the past. The applicant can be enrolled in a college, university, vocational, or trade school. The applicant, their parent, or legal guardian must receive their electric service from Wyrulec Company at their primary place of residence. The applicant, parent, or legal guardian does not have to be a member of the cooperative, as long as they reside on the cooperative's service line. (Can be under a landlord or rental agreement or provided residence with employment.)

### **TRI-STATE GENERATION & TRANSMISSION SCHOLARSHIPS:**

Applicant must be a senior in high school or any eligible college student and must be enrolled or planning to enroll in an accredited university, college, or vocational/technical school. One (1) scholarship will be awarded in the amount of \$1,000.

The applicant, their parent, or legal guardian must receive their electric service from Wyrulec Company at their primary place of residence. The applicant, parent, or legal guardian does not have to be a member of the cooperative, as long as they reside on the cooperative's service line. (Can be under a landlord or rental agreement or provided residence with employment.)

Children of cooperative employees are also eligible to apply for this scholarship.

### **BASIN ELECTRIC POWER COOPERATIVE SCHOLARSHIP:**

Applicant must be a senior in high school or any eligible college student. May be enrolled or planning to enroll in an accredited college, university, vocational/technical school. One (1) scholarship will be awarded in the amount of \$1,000.

The applicant, their parent, or legal guardian must receive their electric service from Wyrulec Company at their primary place of residence. The applicant, parent, or legal guardian does not have to be a member of the cooperative, as long as they reside on the cooperative's service line. (Can be under a landlord or rental agreement or provided residence with employment.)

Children of cooperative employees are also eligible to apply for this scholarship.

**DEADLINE FOR APPLICATIONS IS FEBRUARY 1, 2026. APPLICATIONS WILL BE ACCEPTED AT THE WYRULEC OFFICE UNTIL CLOSE AT 4:00 PM ON JANUARY 30<sup>th</sup>, AND ACCEPTED ONLINE THROUGH THE END OF THE DAY ON FEBRUARY 1<sup>st</sup>.**

- Applications will not be considered unless completed in full and all requirements are met.
- A selection committee outside of Wyrulec staff will choose the recipients.
