

Thank you for contacting Wyrulec Company in preparation of your travel through our service territory. Our Cooperative requires the completion and approval of our Oversize Load Packet in order to assist loads and grant travel through our territory. Within this packet you will find the following forms that must be completed and submitted to our office during business hours and at least 5 business days prior entering our service territory:

- Oversize Load Proof of Notification
- Authorization Agreement for Oversize Load Deposit
- Summary of Standard Charges

In addition to the required forms and deposit process, the following notes and guidelines define our Cooperative's oversize load process:

During the period of May 1st - October 1st, assists will only take place Monday - Thursday. Assists will not take place on weekends or holidays unless special arrangements can be made. If it is determined that we need to de-energize lines in order to facilitate your load, Wyrulec may require a written agreement indemnifying Wyrulec from any liability in facilitating your load or an additional deposit.

Wyrulec Company is required by State of Wyoming regulations to notify all members of planned outages at least 2 business days prior to the scheduled outage.

The Individual responsible or in charge of your load must make telephone contact with Wyrulec Company 24 hours prior to entering our service territory. A follow up call may be required from our Cooperative.

Failure of traveling party to make contact with Wyrulec Company or if party travels through our territory without a Wyrulec escort will result in forfeit your deposit in its entirety. Lack of contact and / or unauthorized travel results in Wyrulec Crews inspecting line of possible damages.

Prior to travel through our territory, Wyrulec requires a safety briefing with both road crew and Wyrulec employees if there is a safe place to do so. This meeting is to coordinate efforts and address safety concerns.

Wyrulec Company does not allow anyone other than our own employees to move or handle our power lines and property.

Pilot cars with an over height measuring stick must wait until Wyrulec crews have lifted the line above the measuring stick prior to pulling away from a power line that needs lifted.
